Proposal Description

The City of Anacortes and Washington Department of Ecology are accepting comments on a periodic review of the City of Anacortes's shoreline master program (SMP) under RCW 90.58.080(4).

The City has prepared draft SMP amendments to keep the SMP current with changes in state law, changes in other City plans and regulations, and other changed local circumstances.

SEPA Threshold Determination

The City of Anacortes has determined that this proposal does not have a probable significant adverse impact on the environment. An environmental impact statement is not required under the State Environmental Policy Act, RCW 43.21C.030(2)(c). This determination of nonsignificance (DNS) was made after review of a completed environmental checklist and other information on file with the lead agency and available upon request.

This determination is issued pursuant to WAC 197-11-340(2). The City of Anacortes will not act on this proposal for 30 calendar days from the date of issuance. The SEPA comment and appeal period runs from November 18, 2020 to December 18, 2020 at 5:00 PM.

How to Comment

Comments are accepted via email, paper, or verbally. All written comments must be received by the deadline and include (1) your full name, (2) your mailing address, and (3) the proposal name (“Shoreline Mater Program Periodic Update”). Comments sent to the City will be forwarded to the Department of Ecology.
