Explanation (attach additional page if response requires more space or for Supplemental Grant requests) We are changing the project from the Anacortes Fire Department effort to prevent, prepare for, and respond to coronavirus due to an inability to adequately store the vaccine to keep it from deteriorating during transport. We are now proposing to redirect funding to 2 new projects as follows: New SOW The City of Anacortes is awarded a \$24,968 CDBG-CV2 Grant. These funds will result in new and increased CDBG-CV2 eligible public services for the City to stabilize eligible households. Major components of the project include: \$16,895 to subrecipient, The Anacortes Senior Center, to fund their remote learning program consisting of activities that have transitioned to an online format since the pandemic. This program will assist seniors with their active participation in social, educational, and physical activities through remote learning. \$8,073 to subrecipient, Anacortes Housing Authority, to provide rental relief for residents who lost income due to Covid and are unable to pay their rent. Eligible public services will benefit a combined total of approximately 86 individuals: 75 seniors and 3 households totaling 11 people. These services will be available to limited clientele with principally low- and moderate incomes based on limited clientele presumed benefit and LMI household qualifications process. CDBG-CV2 funded activities will prevent, prepare for, and respond to coronavirus.
